December 1 is on a Sunday this year. The group would like to aim for a bigger event this year. • CDC Prevention Conference – There was a lot of discussion about PrEP and what the barriers are for keeping non-MSM in PrEP care. Looking at providing incentives to get people in and get tested. They also looked at finding new approaches to targeting high risk areas. • A letter was sent to the administrator of the Volusia County Health Department addressing concerns mainly about staffing levels of leadership and case management in the Ryan White program. The concerns were addressed, and we will stay updated on the progress of the issues being resolved. • The Ryan White program is working on extending approvals from one service date to multiple dates being approved at once.
