We are able to use the Statewide Comprehensive plan as our local plan. Our local CQM is looking at suppressed viral load, timely eligibility and adherence to ART. All of these can be combined to create our Area 12 comprehensive plan.</li> <li>The four key components are:         <ul> <li>Routine HIV testing</li> <li>Test and Treat</li> <li>PrEP and nPEP</li> <li>Community messaging</li> </ul> </li> <li>PLOT is aiming to schedule their meetings on the same day as the PCHAP subcommittee days.</li> <li>The Early Intervention Consultant position will be advertised in the next week or so.</li> </ul>
